#### (Made under section 71)

#### THE VALUERS REGISTRATION (GENERAL)(AMENDMAENTS) RULES, 2022

Citation GN No. 272 of 2019 1. These Rules may be cited as the Valuers Registration (General)(Amendments) Rules, 2022 and shall be read as one with the Valuers Registration (General) Rules, 2019 hereinafter referred to as the "principal Rules".

Amendment of Schedule 2. The principal Rules are amended in the Schedule by-

- (a) deleting figure "19" appearing in the enabling provision and substituting for it with figures "19(1) and 26(1)";
